# **Juvenile Justice Restructuring**

The 82nd Texas Legislature passed a bill that abolished the Texas Youth Commission and the Texas Juvenile Probation Commission and merged these agencies to form the Texas Juvenile Justice Department. The department is statutorily charged with prioritizing community-based programs for juveniles which are both less expensive and more effective than large remotely located state-run lockups.

Among the programs that the new department will support are those that involve training and mentoring for juveniles at the local level and expanded vocational offerings in the remaining state youth lockups.

#### **Seminary Program for Prison Inmates**

A new four-year non-denominational seminary program is being taught in the maximum security Darrington Unit in Rosharon. The 39 inmates in the program are all inmates serving lengthy sentences in a state prison. The seminary program is sponsored by donations from Southwestern Baptist Theological Seminary, Southern Baptists of Texas Convention and the Heart of Texas Foundation.

Early Thursday morning, inmates clad in white jumpsuits paid rapt attention to Phillips as he reviewed the difference between deontological and teleological ethics. At the end of the three-hour class, the inmates stood with bowed heads and hands clasped as Phillips led a prayer. "We pray that you will be glorified in what we have been able to accomplish and that no one will be able to look at what has gone on in this class and this unit and say that it has done anything other than prove that God is awesome," he said. "In Jesus' name."

To qualify for the program, inmates must have high school diplomas or GED credentials, clean behyavioral records for at least a year, a minimum of 10 years remaining until they are eligible for parole and a desire to serve other inmates. The graduates of the program will earn a bachelor of science degree in Biblical Studies and go on to minister to inmates at other prisons.

#### TJJD YOUTH CHARACTERISTICS

from the TYC Annual Treatment Effectiveness Review

Youth adjudicated to TYC have never been typical of the general adolescent population. Many of the characteristics of TYC youth reflect that their unique needs are highly correlated with the probability of future criminal behavior. Most of these characteristics are static factors and cannot be changed, although some can be addressed through treatment intervention. Examples of static risk factors are prior juvenile justice history, prior placements, IQ scores, and history of abuse and neglect.

As a result of reforms, including the emphasis on diversion, TYC youth today are far different from those committed three years ago. TYC has a smaller youth population now, but that population includes a higher percentage of violent offenders. All TYC youth have committed felony offenses. Nearly all have substantial academic deficiencies. Nearly 40% of new commitments report having experienced prior trauma, including sexual abuse. In FY 2010, 92% of new commitments were assessed as needing high or moderate intensity programming in at least one specialized treatment area (capital or serious violent offense, alcohol or other drugs, mental health related issue, or sexual offense), and the figure rose to 98% when low treatment needs were added. The vast majority of youth committed to TYC have had multiple previous encounters with the juvenile justice system. Often, the youth have experienced failure with the education system, their peers, and their communities. For many, TYC is the last opportunity at rehabilitation before entering the adult correctional system. TYC's challenge is to re-engage youth, inspire them, restore their hope, and teach them to believe in themselves - a monumental task for youth who have grown accustomed to failure.

## **Epiphany Evaluation**

At the request of Executive Management, an analysis was conducted to determine if there was an impact upon incidents or recidivism due to the 3-day Epiphany religious program. Anecdotal evidence was that the program substantially reduced the number of incidents immediately after the program.

The analysis examined both the individuals attending the program and the schools overall. It examined the results at four institutions over thirteen occasions of Epiphany programs (Gainesville-7; Hamilton-3; McLennan-2; Giddings-1), comparing the number of documented incidents within the 30 days prior to the program with the number within the 30 days after the program. Only youth at the specific institution from the date 30 days prior to the program through the date 30 days after the program were included. A control group was included of youth in the same institution who did not attend the Epiphany program, but were present for the entire time period of the analysis.

The first analysis examined the effect of Epiphany upon institutional incidents as documented on agency Incident Report Forms. The study compared 420 youth attending the Epiphany program with 2,691 who did not. The effect was examined in two ways, first, the average number of documented incidents 30 days before and after the program, and the percent of youth have any documented incident 30 days before or after the program.

The study also compared the one-year rearrest and the one-year reincarceration rates of each of these youth if they had been released to a non-secure program prior to July 1, 2002, in order to be tracked for one-year prior to July 1, 2003, the last time a year's data is available. Only 586 of the 3,111 youth in the incident comparison had been released prior to that time.

In summary, youth attending the Epiphany program did have an average of 10% less documented incidents within the 30 days after attending, at a time when the incidents of youth not attending increased by 4%. This difference was found to be statistically significant. No statistically significant difference in either one-year rearrest or one-year reincarceration was found for youth attending the Epiphany program.

# Mentoring program offers HPU students opportunity to serve By Courtney Wilmoth, Howard Payne University

BROWNWOOD—A pair of <u>Howard Payne University</u> students who lead a mentoring program for girls at a juvenile correctional facility insist its worth their time investment to let the young women know Christians care about them.

Monique Ching and Ciera Culpepper head the Baptist Student Ministry's mentoring program through the Texas Juvenile Justice Department, working with girls at the Ron Jackson State Juvenile Correctional Complex in Brownwood. The program pairs Howard Payne students with girls at the state school. Each mentor and juvenile offender meet at least one hour a week. The Texas Juvenile Justice Department offers an option for faith-based mentoring, in which a mentor can bring a Bible and discuss matters in a spiritual context.

"The goal is to share Christ with the TJJD students and really love on them in a way they probably have never experienced—with the love of Christ," said Culpepper, a family studies major from Zephyr. In addition to serious discussions about the Bible, mentors also play games and just visit with the juvenile offenders. "This is one of the most rewarding ministries ever," said Ching, a communication major from Hong Kong. "Just being able to hear the girls' stories and be there for them through this time of their life is amazing."

Many of the students at the state school come from troubled or unstable backgrounds, Culpepper added."I think the impact of the program is to provide the TJJD students with safe and healthy relationships," she said. "One of my goals is to get every girl at the state school matched with an HPU mentor."

Allison Voss, chaplain at the Ron Jackson State Juvenile Correctional Complex, values the commitment made by the Howard Payne mentors. "The time and effort spent by mentors at our facility is invaluable," Voss said. "Our students look forward to seeing their mentors each week and develop a strong bond with them. Having a volunteer come and listen and support them makes our students feel valued and loved in a way that many have never experienced before. Howard Payne students are especially an encouragement to our students as they bring with them a sense of youthfulness, energy and diversity."

Although it is a rewarding ministry, the mentoring program demands commitment, participants note. But Culpepper and Ching insist it is worth it. "At the very least, it is showing these girls that someone cares for them," Ching said.

#### The Brain on Trial

David Eagleman (born April 1971in Albuquerque, NM) is a neuroscientist at Baylor College of Medicine, where he directs the Laboratory for Perception and Action and the Initiative on Neuroscience and Law. He is best known for his work on time perception, <a href="mailto:synesthesia">synesthesia</a>, and <a href="mailto:neurolaw">neurolaw</a>. He is a Guggenheim Fellow, a council member in the World Economic Forum, and a New York Times bestselling author published in 27 languages. His brain research centers on the following scientific specializations:

Time perception--Brains do not passively track time--they actively construct it. Eagleman's scientific work combines psychophysical, behavioral, and computational approaches to address the relationship between the timing of perception and the timing of neural signals. In one experiment, he dropped himself and other volunteers from a 150 foot tower to measure time perception as they fell. He writes that his long-range goal is "to understand how neural signals processed by different brain regions come together for a temporally unified picture of the world."

Synesthesia--Sensory stimulation results in unusual sensory experiences. We are using neuroimaging, genetics, and 17,000 synesthetic volunteers to find out why. Synesthesia is an unusual perceptual condition in which stimulation to one sense triggers an involuntary sensation in other senses. Eagleman is the developer of The Synesthesia Battery, a free online test by which people can determine whether they are synesthetic. By this technique he has tested and analyzed thousands of synesthetes, and has written a book on synesthesia with Richard Cytowic, entitled Wednesday is Indigo Blue:

Discovering the Brain of Synesthesia. Eagleman has proposed that sensory processing disorder, a common characteristic of autism, may be a form of synesthesia.

Neuroscience and the Law--How does modern neuroscience change the way we think about the law, criminals, and punishment? Neurolaw is an emerging field that determines how modern brain science should affect the way we make laws, punish criminals, and invent new methods for rehabilitation. Eagleman is the founder and director of Baylor College of Medicine's Initiative on Neuroscience and Law.

Eagleman's extensive article, "The Brain on Trial" which appeared in *the Atlantic*, July/August 2011, provides some extremely interesting reading on neuroscience and the law.

Quotes from this article: "Changes in the balance of brain chemistry, even small ones, can also cause large and unexpected changes in behavior."

"Who you even have the possibility to be starts at conception. If you think genes don't affect how people behave, consider this fact: If you are a carrier of a particular set of genes, the probability that you will commit a violent crime is four times as high as it would be if you lacked those genes. You're three times as likely to commit robbery, five times as likely to commit aggravated assault, eight times as likely to be arrested for murder, and 13 times as likely to be arrested for a sexual offense. The overwhelming majority of prisoners carry these genes; 98.1 percent of death-row inmates do."

Genes are part of the story, but they're not the whole story. We are likewise influenced by the environments in which we grow up.

Substance abuse by a mother during pregnancy, maternal stress, and low birth weight all can influence how a baby will turn out as an adult. As a child grows, neglect, physical abuse, and head injury can impede mental development, as can the physical environment. And every experience throughout our lives can modify genetic expression--activating certain genes or switching others off--which in turn can inaugurate new behaviors. In this way, genes and environments intertwine.

On one end of the spectrum we find people who have suffered brain damage at the hands of fate who did not choose their behavior and at the other end of the spectrum--the "blameworthy" side of the "fault" line--we find the common criminal, whose brain receives little study, and about whom our current technology might be able to say little anyway. The overwhelming majority of lawbreakers are on this side of the line, because they don't have any obvious, measurable biological problems. They are simply thought of as freely choosing actors. Acts cannot be understood separately from the biology of the actors--and this recognition has legal implications.
